Meeting commenced at 5 pm

Introductions

David introduced himself as the new quarry manager at Petrie, he has worked at various Boral sites and has a background in mining. Kate has taken over the stakeholder relations roles for Queensland after Elke's departure.

Operational Update

- Currently working in the RL76 to RL112 levels in the SE area of the quarry
- Working at opening the keyway slot in the N area
- Reasonably strong sales
- Planned 2 week shut end Nov for 2 x screen replacements
- Have a mobile crushing train producing road base and aggregates for the shut period
- The mine inspector visited during Nov 22
- Personal dust monitoring done during Aug 22 on selected employees
- Currently upgrading the wheel wash with a temporary wash working in the interim.
- Water truck running at least three times each day to reduce dust at the site

Environmental Updates

Blast Monitoring – Overpressure

- Overpressure for the period November 2021 to November 2022
- We conducted 13 blasts since our last meeting on June 25 Nov 2021.
- Petrie Quarry approval limits: Overpressure
- must not exceed 120dB(L) for all blasts
- must not exceed 115dB(L) for 9 out of 10 blasts
- All blast overpressure monitoring results were within limits

Blast Monitoring –Vibration

- Vibration for the period November 2021 to November 2022
- Petrie Quarry approval limits: Vibration
- must not exceed 10mm/s for all blasts



Building something great

- must not exceed 5mm/s for 9 out of 10 blasts
- All blast overpressure monitoring results were within limits.

Dust Monitoring

- For the period Feb 2021 to October 2021
- Compliance Limit: 120 mg/m2/day
- All dust monitoring results reported since our last meeting (for the above period) were within compliance limits.
- There were no dust issues reported.

Weed Management

- High volume spraying for lantana, madeira vine, easter cassia, ochna, guava & pepper trees the quarry is trying to remove non native species from the site
- Chain saw & clear larger pepper trees
- Planting Acacia, Shea Oak & Eucalyptus

Current Local Matters / Community Issues

Committee members said they have received no complaints from other residents in the region. Mr King said his electorate office receives some complaints regarding truck movements which always had a quick response from the quarry if contacted, he said no complaints had been received recently. Dave said the quarry takes safe driving very seriously.

Barry gave the committee an overview of fish restocking being done by the Pine Rivers Fish Management Association with 120,000 Australian Bass being released in December and further restocking being done in January 2023.

Other business

Next meeting is to be held in 2022 – Kate be in contact with everyone closer to the date.
